All that certain piece or parcel of Abandoned Erie Canal Land known as that portion of Old Lock House lying south of the appropriation for New Trench in the Town of Brighton in our County of Monroe, declared abandoned

Abandoned by Resolution of the Canal Board of said State adopted October Eighteenth 1871. described as follows to wit Beginning in the north line of highway at a point south twenty eight degrees east from the head of the guard lock and distant therefrom three chains and three links thence along the north line of said road north sixty six degrees east one chain and ninety five links thence north twenty four degrees west one chain and five links thence south sixty two degrees and fifty minutes west one chain and ninety seven links thence south twenty eight degrees east eighty five links to the place of beginning containing about eighteen one hundredths acres

That we have granted, released and quit claimed and By These Presents do grant release and quit claim unto Anson F. Wolcott and George P. Wolcott pursuant to a Resolution of the Commissioners of the Land Office adopted on the Twenty third day of November 1871.

All that certain piece or parcel of abandoned Erie Canal land known as a portion of the Old Seneca River Feeder between the head of said feeder and the present Guard Lock in the Town of Brighton in our County of Monroe, declared abandoned by Resolution of the Canal Board of said State adopted October Eighteen 1871. described as follows to wit Beginning at the intersection of the northerly appropriation ^{line} of the old and new Seneca river feeder at a point at right angles with present guard lock and one chain distant from the face of the north wall of same measured from a point 25 links below the upper hollow groin of said lock thence north 83 and three quarter degrees west five chains and 45 links thence north 86 degrees west four chains and five links thence south 73 and 1/2 degrees west three chains and 55 links thence south 69 and 1/4 degrees west four chains and 75 links thence south 70 degrees west 3 chains and 50 links thence south 52 degrees west two chains and ten links thence south 39 and 1/2 degrees west three chains and 60 links thence south 43 degrees east two chains thence north 39 and 1/2 degrees east three chains and 50 links thence north 52 degrees east one chain and 50 links thence south 48 degrees east 50 links thence north 50 degrees and 58 minutes

east one chain and ten links, thence north 61 degrees and 28 minutes east 4 chains and 5 links, thence north 64 degrees and 28 minutes east 3 chains and 60 links, thence north 82 degrees and 28 minutes east ten chains and 55 links, thence north 84 degrees and 38 minutes east 4 chains, thence south 89 degrees and two minutes east 4 chains and 35 links to the place of beginning, containing about three $\frac{45}{100}$ acres.
